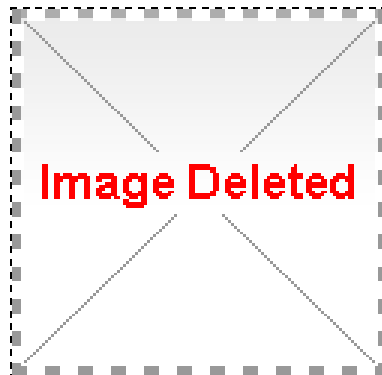
Protect Your Pot of Gold

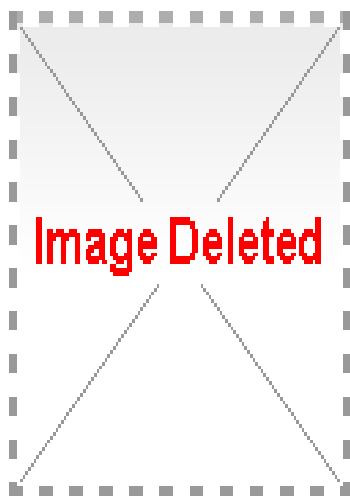

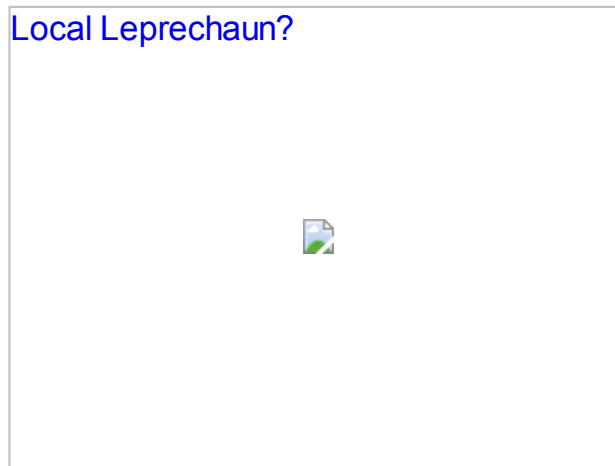
Senior Moments Publications
