

want to make the monthly newsletter your Medicaid application date to see if a penalty period should be imposed. It is readers. What better way possible that the penalty period could be less than five years, so you wouldn't to accomplish that than have to wait five years.

3. You are allowed to give away \$14,000,00 to any number of individuals each year. While that rule is true for IRS purposes, that is NOT true for Medicaid purposes. Remember, what is generally good for tax purposes is generally bad for Medicaid qualification purposes.
